in a writing signed by all the members who would be entitled to

ARTICLES OF INCORPORATION
OF

Ohio State Association of Soldiers Relief Commissioners'

The undersigned, a majority of whom are citizens of the United State, desiring to form a corporation, not for profit, under the GENERAL CORPORATION ACT OF OHIO, DO HEREBY CERTIFY.

FIRST: The name of said corporation shall be: Ohio State Association of Soldiers Relief Commissioners'.

SECOND: The place in this State where the principal office of the corporation is to be located is Toledo, Ohio, Lucas County.

THIRD: The purpose or purposes for which said corporation is formed are:

The purpose of this incorporation is to provide an association for mutual consideration of problems common to all Soldiers Relief Commissions in all of the Counties within the state of Ohio.

To provide assistance and instructions to all the Commissioners' of Soldiers Relief.

To exchange and disseminate information of general use to all Soldiers Relief Commissions.

To maintain a office for general administration, for social, and other purposes and to serve as a liaison between the State and Federal Bureaus in all matters pertaining to the welfare of the Veterans and his dependants.

To maintain contact with all Veterans Organizations.

To furnish contact and information service.

To buy, sell or lease or otherwise hold real estate for the benefit of the association.

To enter into contracts for the benefit of the association.

FOURTH: The following persons shall serve said corporation as trustees: until the first annual meeting or other meeting called to elect trustees.
